Your letter of January 30th received and I am certainly sorry that I was not in the office yesterday when you came in. I arrived a few moments after you left and found that Billy Sharp had settled the situation as far as Moke and Poke and Flo Mayo are concerned.

Now, Mr. Schiffman, I don't know whether one's word means anything in this business or not anymore but if you think back you will have to remember we had a gentleman's agreement whereby I paid you in full for all your advertising on George Dewey Washington when he was supposed to have played your theatre last summer with the understanding that immediately upon his closing his engagement at the Surfside you would give him a week's engagement at the same salary which was \$350. Of course, when Connie Immerman phoned and asked you to cancel George Dewey Washington's booking and you refused to do so, it is really funny to think how important George was to you that particular week and why it should be that he has become so unimportant and valueless to you in the meantime when he has done nothing to warrant this deterioration except receive three plugs in Winchell's column in the past six months. Of course when Herman Stark honed you and asked you to relinquish George that week you did so upon my paying you \$37.50 in full for George's advertising which of course meant nothing to you but it was \$37.50 out of my pocket and not yours or Connie Immerman's, on George Dewey Washington.

Well, it is not up to me to make you change your mind but remember you did make me a promise and I have always kept my word with you on every deal I have ever had regardless of a contract or not but it seems that every time you are sitting in the driver's seat I really have a terrible time as a passenger but I assure you that the situation may be reversed before many months are over and do not misunderstand me but if I should be sitting in the driver's seat you may find the road much bumpier and more shakey in the back seat.

Although I have been unable to get you by telephone during the past week, I thought you might be interested in knowing what I have done.


Since getting your verbal okay to sell "AMATEUR NIGHT IN HARLEM", to be done from the stage of the Apollo Theatre, I have spent a great deal of time in meetings with the Fact-Finding Committee of the unions; have gotten an okay from the Four A's to televise the amateurs at a given fee; have received an okay from the musicians' union to televise the bands at a given fee; and, of course, have been working very closely all this time with the stagehands' union.

In addition, I have made definite pitches to Roy Gordon of the Gordon & Mottner Agency, Dick Marvin of the Grey Agency, Myron Braun of the Sterling Agency. 

Dear Sir,

Mr. Schuyler has asked me to write to you concerning the stage setup for our show. I shall attempt to outline for you the things that we will need that can be prepared for us in advance of our arrival. If these things are taken care of in advance, it will make things much easier for everyone concerned on opening day....

I We will need a large quick change room built on stage, stage right and as close to the portal where Miss Baker will make her entrances and exits as possible. It should contain a full-length mirror, plenty of light, a makeup table, a couple of chairs, and a pipe clothing rack. It should have a sheet or some clean wrapping paper on the floor.

II. If you have an orchestra pit, we will need a 5ft. wide runway built across it, so that Miss Baker can get close to her audience.

III. We will need stairs at both sides of the stage.

IV. We will need the following microphones,

- ① a rising center mike.
- ② a hand mike with a high cut off

of 2 Ft. which we will use in a prop vegetable cart that we carry. It should also have enough cable to reach all over the stage. Both this mike and the hand mike should be connected stage right.

- ④ Two stand mikes, one in either wing and both with enough cable to reach center stage.
- ⑤ Two pickup mikes in the footlights, one on either side of the stage.
- ⑥ We will need a mike attached to an 8 or 10 ft. high column which I will describe later.

II We will need the following colors for the spotlights.


- ① Special Lavender — Rosco #120
- ② Light Pink — Rosco #60 or #112

III We will need an 8 or 10 ft. high column, painted black and with a microphone attached to it at 5 ft. 6 in. from the floor. The mike is attached on a pipe or gooseneck so that it stands 1½ ft. from the column and is perpendicular to the column and faces 45° from straight front. (See diagram on next page).




