# INTRODUCTION

This guide highlights archival collections held at the National Anthropological Archives (NAA) and the Human Studies Film Archives (HSFA) related to the Mandan, Hidatsa, and Arikara. This guide is intended to facilitate research on the highlighted documentation by enhancing the discoverability of materials and efficiency of searches. The materials represented in this subject guide and held at the NAA are not exhaustive, nor are they representative of all the Mandan, Hidatsa, and Arikara documentation in existence. It is also important to understand that given the historical nature of this documentation—these materials were collected and catalogued throughout the nineteenth and twentieth centuries—its metadata reflects terminology in use at the time, which may be at odds with contemporary terminology. This terminology does not reflect the views of the Smithsonian Institution or National Anthropological Archives but is left in its original form to facilitate research. This guide is also a living document, subject to change and revision as staff updates catalog descriptions and access policies, and as further materials are processed and/or acquired by the NAA.

# The NAA welcomes input and edits from Native community members, and works to incorporate these changes into catalog records, access policies, collection information, and subsequently, subject guides. The repository can be reached at (301) 238-1310 or <u>naa@si.edu</u>.

Additional information about each collection is available in the catalog record in Collections Search Center (<u>CSC</u>) or the Smithsonian's Online Virtual Archive (<u>SOVA</u>). Further information for some collections can also be found in finding aids. Although the majority of the collections in this guide have a finding aid linked to them, only some of the finding aids are complete. Those that are incomplete will not provide more information than is in this guide, but those that are complete provide context for the materials described as well as a contents list, usually to the box and folder level, and sometimes to the item level. The National Museum of Natural History (<u>NMNH</u>) and the National Museum of the American Indian (<u>NMAI</u>) also have extensive object collections which can be searched in <u>CSC</u>. NMAI's archival collections can likewise be searched both in <u>CSC</u> and in <u>SOVA</u>.

Some of the materials within the collections of the NAA and HSFA are restricted because either the NAA or the community to which the records relate have deemed the materials sensitive.

# UNDERSTANDING THE EMBEDDED LINKS IN THIS GUIDE

Links through the title of a collection will usually lead you to a record in the Collections Search Center (CSC) for the full collection. In cases where a CSC record does not exist for the full collection, the link will lead you to a set search in CSC which displays the items within the collection that have been catalogued.

Links through the phrase "Finding Aid available through SOVA" will lead you to the finding aid in the Smithsonian Online Virtual Library (SOVA). The finding aid's main page will contain all of the same information as the CSC catalog record, but if the collection is described in more detail, the lower levels of the collection can be navigated more easily through the SOVA record as their hierarchy is visible.

Links through specific items within a collection lead either to that item's record in the SOVA finding aid or to a set search within the SOVA finding aid.

Links through the titles of articles or books will link you to a digital copy of the material.

Finally, links embedded in the name of other institutions will lead you to the websites of those institutions.

# HISTORY OF THE NATIONAL ANTHROPOLOGICAL ARCHIVES

The NAA, along with the HSFA, collects and preserves historical and contemporary anthropological materials that document the world's cultures and the history of anthropology. The materials housed within the NAA include the papers of Smithsonian Institution employees, materials donated by other scholars, and materials copied from other institutions. The NAA is the successor to the archives of the Bureau of American Ethnology (BAE). The BAE was founded in 1879 as the Bureau of Ethnology (the name changed in 1894). It was created by the United States Congress as a subsidiary department of the Smithsonian Institution. The first director, John Wesley Powell (1834-1897), and his staff were concerned that the expansion of white culture into the west would lead to the destruction of Native American cultures and wanted to record them before they disappeared. Powell was primarily interested in recording the languages of Native American tribes and directed his staff accordingly. He created a "schedule" of languages, which today we would call a standardized form. This schedule was a list of words grouped by theme with blank spaces to enter translations. These schedules comprise a significant portion of the BAE's early archival collections and were used in Powell's Introduction to the Study of Indian Languages. In addition to linguistic records, Powell directed his staff to collect cultural objects and specimens, which was the primary interest of the secretary of the Smithsonian Institution. After Powell's death in 1902, the activities of the BAE became less focused, and the staff members began to follow their own interests rather than a single overarching purpose. In 1964, the secretary of the Smithsonian Institution, Dillon S. Ripley (1913-2001), announced that the BAE would be combined with the Department of Anthropology of the National Museum of Natural History. In 1968, The NAA was established, incorporating the collections of the BAE as well as the papers of the National Museum of Natural History's Division of Ethnology (Department of Anthropology). These collections include the Smithsonian's earliest attempts to document North American Indigenous cultures and the cultures of the world. The archival collections of the BAE are known as the Numbered Manuscript Collections. Much of the NAA's current holdings related to language documentation and ethnology were collected and created by Smithsonian anthropologists in the nineteenth and twentieth centuries.

# MANDAN, HIDATSA, AND ARIKARA ARCHIVAL MATERIAL

The NAA recommends that researchers consult with native communities prior to conducting research on those communities in our collections.

Some of the collections at the NAA use terminology which is no longer in use. Materials related to the Mandan, Hidatsa, and Arikara Nation may reference Mandan or Numakiki; Hidatsa, Minitari, Manitaries, Minnetaris, or Gros Ventre; and Arikara, Arikare, Arickara, or Sahnish.

None of the named collections at the NAA contain a substantial body of materials related to the Mandan, Hidatsa, and Arikara. Those with the most material include the John Canfield Ewers papers (primarily related to the Arikara), the James Henri Howard papers, the Donald Jayne Lehmer papers (only Mandan and Hidatsa materials), the Robert Rankin papers (only Mandan and Hidatsa materials), the William Duncan Strong papers, the Williams C. Sturtevant papers (primarily Hidatsa materials, but all three are included), the Waldo R. Wedel and Mildred Mott Wedel papers, and the Garrick Mallery Collection on Sign Language and Pictography (primarily Mandan and Hidatsa). Similarly, no single contributor to the numbered manuscript collections provided a substantial number of materials. The most frequent contributors (contributing to two, three, or four manuscripts each) were James Owen Dorsey, Albert S. Gatschet, Charles Lemon Hall, J. N. B. Hewitt, and Walter James Hoffman. All of these contributors, save Charles Lemon Hall, were employed at the Bureau of American Ethnology. Hall was an architect and missionary who designed the Fort Berthold Congregational Mission. The

collections with the largest number of photographs related to the Mandan, Hidatsa, and Arikara are Photo Lot 24 and Photo Lot 176.

It is important here to note the distinction between a creator and a collector. The creator of an archival collection is generally the person who collected the materials, regardless of who created the materials themselves. Many NAA collections are named for their collectors, who may have created the materials included, collected the materials included, or (most likely) some combination of the two. Where possible, the collections included in this guide list the people who created the materials as "creator" and the people who collected the materials as "collector," though you will find the collectors listed as creators when you follow the links. It is possible, however, that information has been missed in some cases and so may appear misleading.

Some Bureau of American Ethnology manuscripts are being reorganized and redescribed. During this process, some of the links in this guide may get broken. For more information, or to report a broken link, please contact the repository at (301) 238-1310 or <u>naa@si.edu</u>.

# TEXTUAL MATERIALS

<u>Manuscript 246: Vocabulary of the Arikare Language, 1881 September</u> Created by Walter James Hoffman. 12 pages. Finding Aid available through SOVA.

This manuscript consists of Arikara vocabulary with phrases, English translations, and comments.

# Manuscript 257: "Tuwe He" Arikara poem, undated

Collected by Charles Lemon Hall. 1 page. Finding Aid available through SOVA.

This collection contains a news clipping from "Anpo", (Anpao); "Who is He ?"- a poem or hymn, in Ree (Arikara); and a note by J. O. Dorsey- "Full of mistakes, as it went to press without correction."

# Manuscript 418: Arikara Legend: Creation of the World, undated

Created by Stella Bear; collected by Elizabeth C. Sloan. 2 pages. <u>Finding Aid available</u> through SOVA.

This manuscript consists of the Arikara legend of the creation of the world as told by Stella Bear. The legend is written in English.

# Manuscript 559: Poisoned Weapons, undated

Crated by Walter James Hoffman. 19 pages. Finding Aid available through SOVA.

This collection contains extracts from various published sources concerning the use of poisoned weapons among Native Americans. The first six pages include information on the Dakota from non-published sources. Other tribes mentioned include the Mandan.

<u>Manuscript 933-b: Biloxi vocabulary with some cognate forms in Catawba,</u> <u>Santee, Yankton and Teton Dakota, Hidatsa, Kansa and Tutelo In Department of</u> <u>the Interior schedule, 1886 October-November</u>

Created by Albert S. Gatschet; annotated by James Owen Dorsey. 8 pages. <u>Finding Aid</u> available through SOVA.

This collection consists of a US Geographical and Geological Survey "Comparative Vocabulary" schedule<sup>1</sup> with 173 entries. There are corrections of entries ninety-two and ninety-three by J. Owen Dorsey.

Manuscript 934: Vocabulary of the Mandan Collected at Ft. Berthold, D. T., During September 1881, 1881 September

Created by Walter James Hoffman. 10 pages. Finding Aid available through SOVA.

This manuscript consists of Mandan vocabulary with English translations.

<u>Manuscript 1311-a: Long Arm. A Myth of the Hidatsa or Gros Ventre Indians, 1881</u> Created by Charles Lemon Hall. 6 pages. <u>Finding Aid available through SOVA</u>.

This manuscript consists of a Hidatsa legend entitled "Long Arm." The legend is written in English.

Manuscript 1311-b: Ree cosmology. A Myth of the Minnetarris, 1881 March 9 Created by Charles Lemon Hall. 13 pages. <u>Finding Aid available through SOVA</u>.

This manuscript consists of an Arikara legend entitled "Ree Cosmology." The legend is written in English.

# Manuscript 1351: Mandan vocabulary, undated

Created by F. V. Hayden. 5 pages. Finding Aid available through SOVA.

This collection consists of a "Comparative Vocabulary" form with Mandan vocabulary entries.

<u>Manuscript 1352: Comparative Crow and Hidatsa vocabulary, undated</u> Created by F. V. Hayden. 6 pages. <u>Finding Aid available through SOVA</u>.

This collection consists of a printed "Comparative Vocabulary" form containing approximately 165 words in both the Crow and Hidatsa languages.

<sup>&</sup>lt;sup>1</sup> These "schedules" would today be referred to as standardized forms. They were essentially lists of English words, organized thematically, with spaces to enter the translation of the words into native languages.

### Manuscript 1389: Language of the Dakotas and Cognate tribes, 1880s

Created by Alfred L. Riggs. 27 pages. <u>Finding Aid available through SOVA</u>. Digital copies are available.

This collection lists languages of the "Dakotan" [Siouan] stock, makes general observations on them, and compares Dakota, Ponka, Hidatsa, Mandan and Iowa numerals. It also includes marginal queries by James Owen Dorsey.

# Manuscript 1512: Numerals 1-10 in Omaha, Oto, Pawnee, Rickarie and Mandan, undated

Created by Pierre-Jean de Smet. 1 page. Finding Aid available through SOVA.

This manuscript consists of a copy of an original manuscript in the possession of John G. Shea.

Manuscript 1522: Notes on names, and linguistic notes on Siouan, Athapascan, Caddoan, Iroquoian, and Muskhogean tribes, circa 1900

Collected by Francis T. Haggadorn. 256 pages. Finding Aid available through SOVA.

This collection contains vocabularies of multiple Native American languages, including Mandan.

# Manuscript 1585: Research notes compiled by A. S. Gatschet, undated Collected by Albert S. Gatschet. Approximately 100 pages. <u>Finding Aid available</u> <u>through SOVA</u>. Digital copies are available.

This collection contains words and lists of days, months, and years and other time divisions; color adjectives; Totemic clans of all tribes; personal names of chiefs; and personal names of "Knisteneaux or Crees, Shawnee, Crow, Dakota, Arikaras, Cheyennes, Blackfeet, Piegan, Menomoni, Peoria, Otawa, Sauk."

# Manuscript 1647: Miscellaneous materials by Hewitt and others, undated Collected by J. N. B. Hewitt. 1 box. <u>Finding Aid available through SOVA</u>.

This collection contains materials by J. N. B. Hewitt and others which have been tentatively identified and individually cataloged. It includes a <u>Letter to Franz Boas, 1908</u> <u>December 31</u> which concerns Grinnell's publication of the account of the Arikara creation myth received from C. L. Hall.

Manuscript 2028: Notebook containing North American Indian and other vocabularies collected by A.S. Gatschet and others, and miscellaneous notes and bibliographic references, circa 1890s

Created by Albert S. Gatschet, O. Loew, Daniel G. Brinton, and Sir Charles Lyell. Approximately 216 pages. <u>Finding Aid available through SOVA</u>. This manuscript consists of a composition book in the handwriting of A. S. Gatschet. The notebook includes numerous miscellaneous notes, brief bibliographic notes, and notes of an apparently personal nature. It also includes vocabularies for a number of Native American languages, including Hidatsa.

# Manuscript 2372: Garrick Mallery Collection on Sign Language and Pictography, 1849-1902 (bulk 1870-1895)

Created by Garrick Mallery. 41.29 linear feet (22 boxes, 29 folders, 3 mounted drawings, and 3 rolled items). <u>Finding Aid available through SOVA</u>. Digital copies are available.

This collection contains Garrick Mallery's research and writings as a Bureau of American Ethnology (BAE) ethnologist and is largely comprised of correspondence and preparatory materials for publications on Native American sign language and pictography. Manuscript 2522-a: "Tagebuch" or journal of Rudolph Friedrich Kurz, 1846-1852 Created by Rudolf Friedrich Kurz. 455 pages. <u>Finding Aid available through SOVA</u>.

This manuscript consists of a transcript prepared for D. I. Bushnell Jr. from the original manuscript in the Historical Museum, Bern, Switzerland, and sent by Bushnell to the Bureau of American Ethnology in February 1907. The journal was published in <u>Bureau</u> of <u>American Ethnology Bulletin 115 (1937)</u>.

Manuscript 2722: Truman Michelson notes on Hidatsa language, 1912 January 24 Created by Ruth Packineau and Truman Michelson. 1 page. <u>Finding Aid available</u> <u>through SOVA</u>. Digital copies are available.

This manuscript consists of a single page of handwritten Hidatsa linguistic notes from Truman Michelson's research on Algonquian languages at Carlisle Indian Industrial School. These brief notes, which include Hidatsa terms used by females for "my mother," "my father," and "my younger brother," were obtained from Ruth Packineau, a 14-year-old student. Michelson describes the language as "Siouxan Gros Ventre" in his notes.

Manuscript 2932: Notes on sign language and miscellaneous ethnographic notes on Plains Indians, 1934

Created by Hugh Lenox Scott, John Brown Dunbar, He Dog, Red Feather, and Whirling. 4 boxes; 2,736 pages. <u>Finding Aid available through SOVA</u>.

Much of the material in this collection is relevant to the Dakotas. It includes miscellaneous notes on Dakota history, bands, and sign for "Dakota;" an account of the Battle of Little Big Horn by He Dog, Red Feather, and Whirling; "The Custer Battle with the Sioux;" and notes on sign language in general, its history and distribution.

Manuscript 3404: Copy of report to Dr. C. G. Abbott, Secretary of the Smithsonian Institution, on field work done in North Dakota under the direction of the Logan Museum of Beloit College, Beloit, Wisconsin, at the Greenshield and Hensler or Van Oosting sites, 1929 December 31

Created by Alfred W. Bowers. 7 pages (12 photographs). <u>Finding Aid available through</u> <u>SOVA</u>.

This manuscript consists of a report on fieldwork done at the Greenshield site and Van Oosting site in North Dakota. The Greenshield site was an Arikara village occupied in 1795-1799 and 1835-1837, and the Hensler or Van Oosting site was a Mandan village, occupied and abandoned before white contact.

Manuscript 3409: Notes on Indian delegations visiting Washington during the presidency of Thomas Jefferson [1812 ?], undated Created by Augustus John Foster. 18 pages. Finding Aid available through SOVA.

This manuscript contains an account of the Osage and Mandan delegates brought to Washington in 1806 by Meriwether Lewis, as well as notes on Southeastern tribes, Delaware, and Pawnee.

# Manuscript 3437: Nomina verbalia with their verb-bases. Extracted as examples for the Bureau of American Ethnology from (chiefly) North American languages, 1895

Collected by Albert S. Gatschet. 24 pages. Finding Aid available through SOVA.

This collection contains terms expressing actors, actions, etc. in Isleta, Arapaho, Nahuatl, Delaware, Penobscot, Passamaquoddy, Maya, Quiche, Kechua, Ojibwa, Kataba, Tonkawa, Dakota, Shawnee, Peoria, Blackfoot, Cree, Micmac, Peoria, Hidatsa, and Wichita. It includes 1 page (page 22) on Hidatsa.

# Manuscript 3931: Miscellaneous vocabularies, undated

Collected by J. N. B. Hewitt. 1 box. Finding Aid available through SOVA.

This collection contains vocabulary on cards compiled from information furnished in reply to letters of inquiry. The information is secondary and lacks documentation. Arikara and Mandan terms are thought to be included.

Manuscript 4166: Letter to John R. Swanton enclosing typed copies of reports on the Alabama, Koasati, and Muscogee Indians of Texas, undated

Created by W. C. Philips, Captain Samuel M. Whiteside, and Grant Foreman; collected by John Reed Swanton. 1 item (2 1/2 pages). <u>Finding Aid available through SOVA</u>. Digital copies are available.

This manuscript contains reports on the Alabama, Koasati, and Muscogee and a report on the Pima, Maricopa, and Arikara, concerning efforts to interest these tribes in removing to Indian Territory.

### Manuscript 4538: English-Arikara vocabulary, 1869-1874

The creator of this manuscript is unknown. 36 pages. <u>Finding Aid available through</u> <u>SOVA</u>.

This manuscript consists of an English-Arikara vocabulary. It was previously identified as being by Washington Matthews as it was given to the Bureau of American Ethnology by Dr. Pope with a copy of Matthews' "Grammar and Dictionary of the Language of the Hidatsa," New York, 1873, but this attribution is now questioned.

# Manuscript 4558: Alice Cunningham Fletcher and Francis La Flesche papers, 1873-1939

Created by Alice Cunningham Fletcher and Francis La Flesche. 19 linear feet (50 boxes). <u>Finding Aid available through SOVA</u>. Digital copies are available.

These papers reflect the professional lives of Alice Cunningham Fletcher (1838-1923), an ethnologist with the Peabody Museum of Harvard University and collaborator with the Bureau of American Ethnology (BAE), and Francis La Flesche (1856-1923), an anthropologist with the BAE. Included in the collection is correspondence, personal diaries, lectures, field notes and other ethnographic papers, drafts, musical transcriptions, publications by various authors, maps, and photographs. Materials related to the Mandan and Hidatsa can be found in <u>Series 1: Alice Cunningham Fletcher papers / 1.1: Incoming correspondence, 1873-1925 (bulk 1882-1923)</u>.

### Manuscript 4800: James O. Dorsey papers, circa 1870-1956 (bulk 1870-1895)

Created by James Owen Dorsey. 30 linear feet (70 boxes, 1 oversized box, 20 manuscript envelopes, 4 rolled maps, and 23 map folders). <u>Finding Aid available through SOVA</u>. Digital copies are available for some materials.

This collection contains James O. Dorsey's research and writings as a Bureau of American Ethnology (BAE) ethnologist, as well as his earlier work as a missionary among the Ponca. The vast majority of the collection pertains to his research on Siouan-Catawban languages, including Mandan and Hidatsa. Dorsey's research files include linguistic and ethnological field notes, reading notes, stories and myths, vocabularies, drawings, and unpublished and published manuscripts. Materials related to the Mandan, Hidatsa, and Arikara can be found in the following locations:

- <u>Series 1: Siouan-Catawban / 1.6: Tutelo, Biloxi / Biloxi and Hidatsa comparisons,</u> <u>undated</u>

# Manuscript 7014: Extract from "Travels in the Interior of North America" concerning the medicine stone near Cannonball River, North Dakota, undated Created by Maximilian, Prinz von Wied. 1 page. Finding Aid available through SOVA.

This manuscript consists of the first page of a paper entitled "Oracle stones and offerings." The contents of the paper concern the "Medicine Stone" of the Hidatsa which lies "between two and three day's journey from the villages on Cannon-ball River."

Manuscript 7060: Copy of typescript of "Village movements of the northern horticulturists (Mandan and Hidatsa), 1675 to 1860" and a corrected copy of "Mandan and Hidatsa villages in the Eighteenth and Nineteenth Centuries," by Frank Henderson Stewart, undated

Created by Frank Henderson Stewart. 106 pages. Finding Aid available through SOVA.

This collection contains "Village movements of the northern horticulturists (Mandan and Hidatsa), 1675-1860" (manuscript), which was published in *Plains Anthropologist*, 1974, and "Mandan and Hidatsa villages in the Eighteenth and Nineteenth Centuries" (corrected typescript). The manuscript is an extended version of the typescript.

# Manuscript 7504: The 17th Annual United Tribes International Powwow, Bismarck, North Dakota, 1986

Created by Portia Sciacchintano. 40 pages. Finding Aid available through SOVA.

This manuscript consists of a description of a powwow sponsored by the United Tribes Educational Technical Center and people at the powwow, including David Gipp, Mandan, president of the center; Randy Plume, a Pine Ridge Sioux, director of the powwow; and Alyce Spotted Bear, the chairman of the Three Affiliated Tribes.

Archaeology reports and related material collection, circa 1970-circa 1990 Collected by the Smithsonian Institution's Department of Anthropology curators, the National Anthropological Archives, the Smithsonian Institution's Anthropology Library, and the National Park Service Anthropology program. 111.5 linear feet. Finding Aid available through SOVA.

With the passage of federal environmental and cultural heritage legislation during the 1960s, 1970s, and 1980s, archaeological investigations were required before federal land could be disturbed for construction projects. Reports of these investigations, often conducted by archaeological contactors, were generally published in processed rather than printed form. Included in this collection are reports on this archaeological work. The papers relate closely to the Edward S. Curtis papers at the <u>University of</u> <u>Washington Libraries Special Collections</u>. The research notes consist of a small mixture of writings on field experiences as well as maps used during his fieldwork (the bulk of Curtis' fieldnotes and *NAI* manuscripts are at the <u>Seaver Center for Western History</u> <u>Research at the Los Angeles County Museum of Natural History</u>). The *NAI* files chiefly contain material promoting the work, such as published reviews, articles, and ephemera (the bulk of the business records are maintained at the <u>Morgan Library</u>). # John Peabody Harrington papers, 1907-1959 (some earlier)

John P. Harrington was a Bureau of American Ethnology ethnologist involved in the study of over one hundred Native American tribes. His specialty was linguistics. Most of the material in this collection concerns California, southwestern, and northwestern tribes. Also of concern are general linguistics, sign language, and writing systems. Certain themes frequently appear in his work, including annotated vocabularies concerning flora and fauna and their use, topography, history and biography, kinship, cosmology (including tribal astronomy), religion and philosophy, names and observations concerning neighboring tribes, sex and age division, material culture, legends, and songs. # **GRAPHIC MATERIALS**

The NAA has extensive photographic collections. Description and arrangement of photographic collections vary widely depending on the circumstances of creation, collection, and accession into the NAA. The records described below should be considered starting points for research; they should not be considered a comprehensive list.

Researchers looking for more specific images will probably be best served with keyword searches of the Smithsonian's Collection Search Center (<u>CSC</u>) because a large number of photographs have been given item-level catalog records. We suggest using specific terms (e. g. "Mandan" or "Hidatsa" or "Arikara" + "basket") and narrowing the results by using "National Anthropological Archives" as the catalog record source and "Photographs" as type. Collections with item level inventories in their finding aids can also be searched within the SOVA record by typing a search term (e. g. "Mandan" or

"Hidatsa" or "Arikara") into the "Search within collection" field underneath the collection title.

Please note that any Photo Lot number preceded by the letter "R" represents a reproduction of a collection held at another repository.

### Manuscript 39-d-2: Drawings by Tichkematse and others, undated

Created by Tichkematse and other unidentified artists. 13 drawings (12 leaves, graphite, crayon, watercolor, and ink, 20 x 23 cm-22 x 54 cm). <u>Finding Aid available through</u> <u>SOVA</u>. Digital copies are available.

This collection contains thirteen drawings, primarily scenes of warfare. Ten of the drawings are heavily water and mildew damaged, now laminated. The origin of the drawings and their association to each other is not recorded. <u>Anonymous small</u>, <u>indistinct drawings</u>, <u>possibly Arikara</u>, <u>undated</u> includes scenes, most if not all of which match with copies of scenes from Bloody Knife's robe.

# Manuscript 1929-a: Drawings of war deeds of Sitting Bull and Jumping Bull, circa 1870

Created by Jumping Bull and Sitting Bull; collected by James P. Kimball. 55 drawings (54 leaves, ink and colored pencil). <u>Finding Aid available through SOVA</u>. Digital copies are available.

This collection consists of fifty-five copies of drawings of war deeds of Sitting Bull and Jumping Bull on fifty-four leaves: fifty-three drawings are on blank backs of printed roster sheets for the 31st US Infantry, dated 1868; one leaf has drawings on both sides; one unfinished drawing is on an abstract of an Army order dated 1868. The collection also includes a seven-page handwritten explanation by Kimball, based on information gained from Native community members, interpreters, and others at Fort Buford; an 1881 letter from the Reverend John Williamson, regarding his interview with Sitting Bull; and typed notes from Matthew Stirling (circa 1930s). <u>Sitting Bull counting coup on an Indian enemy</u>, 1870 includes a depiction of an Arikara enemy.

# Manuscript 1929-b: Sitting Bull pictographic autobiography and related material, 1882-1923

Created by Sitting Bull. 22 drawings (graphite, colored pencil, and ink, 21 x 34 cm). Finding Aid available through SOVA. Digital copies are available.

This collection contains pictures of Sitting Bull's war deeds, drawn by himself, with accompanying explanations. Each sheet is autographed in cursive handwriting by Sitting Bull. The scenes are not in chronological order. The pictures were originally drawn on the front leaves of a bound volume of ruled paper and were removed by the archives for lamination. The remaining volume has eight leaves with mounted newspaper clippings about Sitting Bull, and many additional blank leaves. Arikara individuals are depicted in In battle with Arikaras, striking down Bull Head, 1882.

Collected by Edwin Thompson Denig. 37 drawings (graphite and ink, pasted onto 19 mounts, mounts 18 x 22 cm.-36 x 24 cm). <u>Finding Aid available through SOVA</u>. Digital copies are available.

This collection contains the original drawings that accompanied Edwin Thompson Denig's 451 page manuscript, entitled "Report to Hon. Isaac I. Stevens, Governor of Washington Territory, on the Indian Tribes of the Upper Missouri, by Edwin Thompson Denig." The drawings depict utensils, tools, game pieces, plants, warfare, hunting, a tipi, a scalp dance, and a map. Five of the drawings are attributed to anonymous Assiniboine artists. The drawings that are not attributed to the Assiniboine may have been drawn by Edwin T. Denig. The manuscript was published in the *Forty-sixth Annual Report of the Bureau of American Ethnology* (1930). Anonymous Assiniboine drawings of Arikara ear ornament and cooking vessels from several tribes, circa 1853 includes five drawings on 1 mount inscribed "Arickara Ear Ornament," "Arickara Clay Pot," "Clay Corn Mortar," "Grossventre Stone Mortar," "Assiniboine Buffalo Horn Spoon," and "Assiniboine Big Horn Spoon, 3 pints."

Manuscript 3034: Manuscript on the Arikara Indians of the Dakotas, undated Collected by Robert W. Jones. 5 pages. <u>Finding Aid available through SOVA</u>.

This collection contains four photos showing pottery and implements, and one of W. H. Over, who conducted the investigation.

# Manuscript 4109: David Ives Bushnell, Jr. collection of drawings and illustrations, 1784-1869, undated

Created by David Ives Bushnell. 16 engravings, 6 drawings, and 2 photographs. <u>Finding</u> <u>Aid available through SOVA</u>.

This collection consists of a package of sixteen folio-sized engravings based on drawings by John Weber. It includes a watercolor titled "Mah-to-toh-pa, Chief of the Mandans."

Manuscript 4234: Comparative notes on Siouan languages, undated Created by John Reed Swanton. 8 slips. <u>Finding Aid available through SOVA</u>.

This collection contains comparative vocabularies, one of which includes terms in Hidatsa and Mandan.

Manuscript 4420: William Henry Jackson photograph albums based on his Descriptive Catalogue of Photographs of North American Indians, circa 1877

Created by William Henry Jackson. 9 albums; approximately 4,000 albumen prints (some copies). <u>Finding Aid available through SOVA</u>.

This collection consists of albums, probably assembled by William Henry Jackson, mostly containing portraits of Native American delegates in Washington, DC, and photographs made on US Geological Surveys (including the Hayden and Powell surveys). The albums were probably assembled by Jackson while he worked for the United States Geological Survey of the Territories. Some of the albums include captions pasted from Jackson's <u>Descriptive Catalogue of Photographs of North American Indians</u> (1877) while others have handwritten captions.

Restrictions: This collection contains images that may be culturally sensitive, including images of human remains.

# Manuscript 4605: James E. Taylor scrapbook of the American West, circa 1863-1900

Created by James E. Taylor. 4 tintypes, 3 chromolithographs, 3 chalk-manner lithographs, 1 photogravure print, 118 pages (scrapbook), approximately 685 albumen prints, approximately 80 relief prints (including woodcuts and wood engraving), and approximately 30 intaglio prints (including etchings and engravings). This manuscript consists of a scrapbook entitled "Our Wild Indians in Peace and War: Surveys, Expeditions, Mining and Scenery of the Great West," compiled by James E. Taylor, possibly as a source for his own illustrations. The album includes photographs, newsclippings, wood engravings, and lithographs, some of which are reproductions of Taylor's own illustrations and paintings. Photographs depict Native Americans, US Army soldiers and scouts, historical sites, forts, and scenery. Some were made on expeditions, including the Hayden and Powell surveys, and created from published stereographs. The collection includes <u>five photographs of individuals identified as</u> <u>Hidatsa</u> and <u>two of individuals identified as Arikara</u>.

# Manuscript 4722: Photographs taken at Standing Rock Reservation, 1927 and 1932 and one Mandan photograph, undated

Created by Clyde Fisher. 15 photographs. Finding Aid available through SOVA.

This collection includes the photograph <u>Replica of Earth Lodge and Corn Drying</u> <u>Scaffold on Capitol- Grounds, undated</u>. This collection is now included in <u>Photo Lot 24</u>.

# Manuscript 154064: Arikara and Cheyenne drawings collected by William Babcock Hazen, circa 1875

Created by Fort Marion artists; collected by William Babcock Hazen. 3 volumes; 81 drawings. <u>Finding Aid available through SOVA</u>. Digital copies are available.

This collection consists of three volumes of drawings collected by William Hazen around 1875. Two of the volumes are by Arikara artists; one volume is a by a Cheyenne prisoner at Fort Marion. The collection was identified by the donor, Mildred Hazen, as Sioux material collected by her late husband Gen. William B. Hazen during his military service in the West. The original identification of these books as Sioux has been changed as the style of dress, body decoration, and hair are not consistent with that tribe. Two of the books are consistent with an identification as Arikara made by Candace Greene in 2004. During the 1870s many Arikara men enlisted as scouts with the U.S. Army and a number were posted at Fort Buford during the time that the collector was there. Both books contain pictures of friendly encounters with Army officers, and one (08510521) depicts an Indian scout in uniform. The third book has been identified as Cheyenne on authority of Karen Peterson and Ray DeMallie, Guide to Siouan Manuscripts (1969). Per Father Peter Powell (October 1971) the drawings are Chevenne, probably by Cohoe and certainly by a Fort Marion prisoner. The Sun Dance scene was verified as Cheyenne by William Fletcher and Gordon Yellowman, Cheyenne Sun Dance priests, in 2000.

# Manuscript 384176: Plains Indian drawings of horses in book made of forms, 1880-1884

Collected by D. H. Brotherton. 6 drawings (4 leaves, graphite, colored pencil, and crayon, 21 x 26 cm). <u>Finding Aid available through SOVA</u>.

This collection consists of six Plains Indian drawings on the leaves of a book. The paper is unused forms for reports of Quartermaster's Stores. The drawings are all of horses, with faint figures of a courting couple in one image. The authorship of the drawings is unknown. They appear to be by two hands, one of whose work also appears in <u>Manuscript 384177</u> and <u>Manuscript 28804</u>. The original identification as "Sioux," subsequently changed to the more specific Lakota, but may be in error. Other possible tribal origins include Arikara.

# Manuscript 384177: Anonymous drawings, possibly Lakota, on pages of book made of printed forms for Property Return, circa 1880-1884

The creator of these drawings is unknown; collected by D. H. Brotherton. 9 drawings (8 leaves, graphite and colored pencil, 26 x 24 cm). <u>Finding Aid available through SOVA</u>.

This collection contains Plains Indian drawings on the leaves of a book created by stitching together four folded sheets of printed forms. The paper is unused forms for ration issue at Fort Peck, Montana. The drawings are of intertribal warfare, the capture of horses, and a meeting between Brotherton and an Indian leader, identified in an inscription as Wetcohu or Wetcohee. The authorship of the drawings is unknown. They appear to be by a single hand, whose work also appears in <u>Manuscript 384176</u> and <u>Manuscript 28804</u>. The original identification as "Sioux" was subsequently changed to the more specific Lakota but may be in error. Other possible tribal origins include Arikara.

# Photo Lot 6A: United States Army Medical Museum composite photographs of skulls, circa 1884-1885

Created by the United States Army Medical Museum. Approximately 78 albumen prints. Finding Aid available through SOVA.

This collection contains <u>US Army Medical Museum</u> photographs prepared under the supervision of John Shaw Billings and Washington Matthews. They were created by superimposing images of several skulls for comparative purposes. Each image has a caption that includes tribal or racial identification, the number of skulls photographed, a photograph number, a negative number, and data on the photographic technique. This collection includes <u>nine photographs of skulls identified as belonging to Hidatsa</u> individuals.

Restrictions: This collection contains images of human remains.

# Photo Lot 24: Photographs of Native Americans and Other Subjects, 1840s-1960s

This is an artificial collection<sup>2</sup> comprised of works by multiple creators. Approximately 18,000 items. <u>Finding Aid available through SOVA</u>. Digital copies are available for some images.

This collection consists mostly of original and copy prints. There are also some negatives, artwork, photographs of artwork, and printed materials. Included is a large miscellany of ethnological, historical, and some archaeological subjects collected by the Bureau of American Ethnology from a wide variety of sources. Although most of the material relates to North America, some images relating to historical events and to areas outside North America are included. This collection consists of photographs relating to Native Americans, which were submitted to the copyright office of the Library of Congress in and around the early 20th century. Many of the photographs are studio portraits as well as photographs made as part of expeditions and railroad surveys. It includes images of people, dwellings and other structures, agriculture, arts and crafts, burials, ceremonies and dances, games, food preparation, transportation, and scenic views. The collection includes <u>nineteen</u> photographs by Edward Curtis and two by other photographers related to the Mandan, eighteen by Edward Curtis related to the Hidatsa, and <u>forty-five by Edward Curtis</u> and two by other photographers.

Restrictions: This collection contains images that may be culturally sensitive.

# Photo Lot 64: Rodman Wanamaker photograph collection relating to Native Americans, 1908-1909

Created by Rodman Wanamaker. 154 silver gelatin prints. <u>Finding Aid available through</u> <u>SOVA</u>.

This collection contains photographs commissioned by Rodman Wanamaker to document the "vanishing" way of life for Native Americans during 1908-1913. The photographs were made by Joseph Kossuth Dixon and largely depict northern Plains tribes. The collection includes two photographs related to the Hidatsa.

# Photo Lot 73-8: John N. Choate photographs of Carlisle School students, circa 1879-1902

Created by John N. Choate. 30 mounted albumen prints (boudoir cards, cabinet cards, and cartes de visite). Finding Aid available through SOVA.

This collection contains photographs depicting students in the Carlisle Indian Industrial School in Pennsylvania, many with handwritten notation identifying pictured individuals. Included are individual and group portraits of students. The collection includes <u>two</u> <u>photographs related to the Hidatsa</u>.

Photo Lot 73-9: Photographs of students at Hampton Institute, circa 1879-1880 Created by the Hampton Institute. 2 albumen prints. <u>Finding Aid available through</u> <u>SOVA</u>. This collection contains photographs depicting students on arrival at the Hampton Institute and again eighteen months later. Identifications of individuals are printed on the verso.

# Photo Lot 73-26C: United States Army Medical Museum photographs of skulls, circa 1870s-circa 1880s

This collection contains photographs of skulls in the <u>United States Army Medical</u> <u>Museum</u> collection, which appear to have been collected for physical anthropological purposes. ### INDEX TO NAMES

This index is not comprehensive, but includes all indigenous groups discovered by the archivist within the collections while the guide was being assembled. There may be other names within collections that have not been recorded and some of the photograph collections include photographs of unidentified Mandan, Hidatsa, and Arikara people. The index is intended to facilitate access to the collections, and every effort has been made to ensure it is accurate, but there may be some errors. Anglo or partially Anglo names are alphabetized by the last name (i.e. "Anderson, Carrie" or "Bear Eagle, Stella"). Where both a Mandan, Hidatsa, or Arikara and English version of a name are available, the Mandan, Hidatsa, or Arikara version is given preference and there is a reference to it under the English version (i.e. the entry for "Lean Wolf" is "see Cheshakhadakhi (Lean Wolf)" and the entries for "Dawson, Anna R." and "Wild Rose" are "see Spa-Ha-Na-Na-Da-Ka (Wild Rose), called Anna R. Dawson"). If multiple spellings of a name are used, one of them has been given preference and the others refer back to it (i.e. the entries for "Sha-ha-ka (chief)" and "Sheheke (chief)" are "see Shahaka (chief)"). Titles are given in parentheses after the name (i.e. "(chief)" or "(Mrs)"). In cases where individuals are defined by their relationship to others, they will be listed as the wife, daughter, son, etc. of the person (i.e. "Eagle Woman's daughter"). In some cases, this will refer back to the individual by their own name (i.e. the entry for "Dawson, Annie's mother" is "see Dawson, Mary" and the entry for "Little Crow's
daughter" is "see Styles, Lottie"). There are also instances where two versions of names are listed for what are likely the same person, but they are given separate entries with their associated collections in case they are not (i.e. "Mat'o-tope (chief)" and "Mato-Topi (chief)" or "Ku-Nugh-Na-Give-Nuk (Rushing Bear)" and "Ku-Nugh-Na-Give-Nuk (Rushing Bear)" or (Son of the Star)"). Names were copied precisely as written despite inconsistencies between collections.
